#### **Daniel T. Ariens**


Daniel T. Ariens at age 40, became president & Chief Executive Officer of Ariens Company in March 1998. He has served as a member of Ariens Company's Board of Directors since 1996.

Dan has been with Ariens since 1984 where he made his start as a marketing and sales territory manager for the Gravely division of Ariens Company. He has also served in roles at Ariens as manager of retail and wholesale credit and receivable and as Vice President - Manufacturing. As manufacturing leader, in additions to implementing World Class Manufacturing initiatives the integration and consolidation of Gravely manufacturing operations in Clemmons NC into the Ariens manufacturing in Brillion, Wisconsin was accomplished.

Later Dan lead in dual roles as Vice President – Engineering of the newly combined Ariens and Gravely engineering services and the Vice president of the Parts and Accessories Division. While creating a service parts division, the opportunity to acquire an aftermaket parts business was born and Stens was acquired in 1995. Dan led the acquisition and integration transition as President of Stens Corporation in Jasper Indiana until March of 1998.

In addition to his work at Ariens Company, Dan Serves on the Board of Directors of the Weidner Center, A performing arts center in Green Bay, Wisconsin. He is also a member of the International and Wisconsin Chapter of Young Presidents' Organization (YPO) and is a member of Wisconsin Manufacturers and Commerce.

Dan graduated from the University of St. Thomas in St. Paul, Minnesota in 1981 where he earned a degree in Finance and Business Administration.


