

KEN MOEHLE



December 1998 Meeting

The December program, thanks to the efforts of the Milwaukee Section Secretary Alicia Muszynski, will be hosted by the Case Corp. of Racine, Wisconsin. Case is one of the world's largest suppliers of agricultural and construction equipment with headquarters in Racine, Wisconsin, and employs over 17,000 people worldwide.

Case was founded in 1842 by Jerome Increase Case (JIC) to build threshing machines and has since expanded into other agricultural lines and construction equipment. The Case Corp. is listed on the NYSE and is lead by President and CEO Steve Lamb who was this year's Off-Highway and Powerplant Congress Engine Exposition Honorary Chairman. Case is a leading manufacturer of mid-sized construction equipment and is the second largest manufacturer of agricultural equipment including the award-winning Magnum tractor that is the focus of this month's program.

At a recent Governing Board meeting, the Board agreed with the Program Committee's recommendation to not have a program in January due to weather concerns and the feeling that members would appreciate a break after the holiday season.
